## UGC REGULATIONS ON MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHERS AND OTHER ACADEMIC STAFF IN UNIVERSITIES AND COLLEGES AND MEASURES FOR THE MAINTENANCE OF STANDARDS IN HIGHER EDUCATION, 2018

### MINIMUM QUALIFICATIONS FOR THE POSTS OF DIRECTOR OF PHYSICAL EDUCATION AND SPORTS (DPES)

#### Director of Sports and Physical Education - 01 :

- i) A Ph.D. in Physical Education or Physical Education and Sports or Sports Science.
- ii) Experience of at least ten years in Physical Education and Sports as University Assistant/Deputy DPES or ten years as College DPES or teaching for ten years in Physical Education and Sports or Sports Science as Assistant/Associate Professor.
- iii) Evidence of organizing competitions and coaching camps of at least two weeks' duration.
- iv) Evidence of having produced good performance of teams/athletes for competitions like state/national/inter-university/combined university, etc.

#### Physical Fitness Test Norms:

- (a) Subject to the provisions of these Regulations, all candidates who are required to undertake the physical fitness test are required to produce a medical certificate certifying that he/she is medically fit before undertaking such tests.
- (b) On the production of such certificate mentioned in sub-clause (a) above, the candidate would be required to undertake the physical fitness test in accordance with the following norms:

1. The Candidate must apply online. Only online application with required uploaded enclosures will be accepted.
2. Last Date for receipt of Applications online on or before 05/01/2026 till 06:00 p.m. and submission of hard copies of the application on or before 15/01/2026 till 06.00 p.m.
3. Applications received after the last date and time mentioned above will be rejected.
4. The Appointment of the Director of Sports and Physical Education shall be for a term of five years or the age of superannuation, whichever is earlier, and he shall not be eligible for re-appointment in that university.
5. The Selected candidates shall be appointed under written contract.
6. The regulations/norms and other service conditions prescribed in the present advertisement are as per the Notification **THE GUJARAT PUBLIC UNIVERSITIES UNIFORM STATUTES, 2024** and **UGC REGULATIONS ON MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHERS AND OTHER ACADEMIC STAFF IN UNIVERSITIES AND COLLEGES AND MEASURES FOR THE MAINTENANCE OF STANDARDS IN HIGHER EDUCATION, 2018 (18th July, 2018)**, and subsequent amendments from time to time till the last date of receiving application.
